## **Important Notes**

Metis Global (Singapore) Pte. Limited ("Metis SG") is required to collect certain information about your tax residency in order to comply with the Singapore Income Tax Act (Chapter 134) and related regulations including Income Tax (International Tax Compliance Agreements) (United States of America) Regulations 2015 (FATCA) and Income Tax (International Tax Compliance Agreements) (Common Reporting Standard) Regulations 2016 (CRS).
